Your company is cordially invited to exhibit at the **26th Annual Plant Operations Conference** sponsored by the Virginia Section AWWA Plant Operations Committee. The event will be held May 6-8, 2026 at the Hilton Garden Inn Virginia Beach Oceanfront 3315 Atlantic Ave. Virginia Beach, VA 23451.

This conference is dedicated to promoting education and training, increasing performance, and fostering communication among water works operators, maintenance, and management personnel. Attendance is recommended for waterworks operators of both small and large groundwater and surface water systems and their supervisors. Ten hours of water operator continuing professional education credits are offered, providing great value for those needing CPE credits to meet license renewal requirements. Additionally, there is a session on regulatory updates and a management-focused session draws supervisory-level attendees.

A unique feature of this conference is the Top Ops Competition which is conducted to find the Top Operators in Virginia to represent the Virginia Section at the AWWA Annual Conference and Exposition (ACE). Small teams compete against each other to correctly answer math and content questions like those found on the Waterworks Operator exam. Trophies are awarded for 1st, 2nd and 3rd place and winners receive financial assistance to compete at the national event the following year.

A small exhibition area will be set up immediately outside the classroom area to provide an opportunity for attendees to learn more about products and services that may benefit their organization. The number of exhibitors in this area will be extremely limited to increase the value for all that attend. Breakfasts, breaks and lunches will be held near this area to maximize the available time for interaction between exhibitors and attendees.

This event includes opportunities for casual networking. On the first night, attendees will enjoy a cocktail reception at the host hotel. The program ends at 2 pm each day to give attendees time to catch up with colleagues. Both Exhibitors and Sponsors will be provided with an attendee list and are encouraged to participate in technical sessions and meals. Exhibitors and Sponsors will be graciously acknowledged in the opening remarks.
